- Problem Solving You can't let your problems be a problem;
- Relationships If you get along, they will go along;
- Responsibility A leader can give up anything except final responsibility;
- Security No one will make a great leader who wants to do it all himself or get all the credit for doing it;
- Self-discipline The first person you lead is you;
- Servanthood- To get ahead, put others first;
- Teachability To keep leading, keep learning
- Vision You can seize only what you can see.

Did you know that DCPA has a member-only certification scholarship fund?

Applicants must meet the following requirements:

- (1) Must be currently enrolled as a member in good standing now and in the previous year,
- (2) Must be working as a paralegal in Denton County TX
- (3) Must be enrolled to sit, or have recently sat for a recognized paralegal certification examination (i.e., NALA, NFPA or TBLS) and must attach a copy of the exam application fee receipt to the scholarship application,
 - a. NALA Exam

Application filing deadline	Exam Date (Varies)
August 1 st	September 1-30
December 1 st	January 1-30
April 1 st	May 1-31

b. TBLS Exam

Application filing deadline	Exam Date (Varies)
May 12 th	November 8th

Recipient(s) of the scholarship are selected at the sole discretion of the DCPA Executive Committee and will be announced at the October meeting.

NOTE: The application must be received by the Executive Committee on or before September 15th of the current year.

Minutes

NEW BUSINESS:

- 5. President Guertler discussed delaying the legal directory publication until January 2015 so that the publication is updated and complete following elections. Member Gloria Porter mentioned that publishing in January 2015 would actually return to the original publishing schedule since most recently we published directories two years in a row, rather than our planned biannual publication. President Guertler asked for a vote for the legal directory to be published in January 2015. Member voted unanimously to approve publication in January 2015. - 6. President Guertler announced that the committees need additional volunteers. If you are willing to help, please contact the committee chair of your interested committee or a member of the executive committee.
- 7. Michelle Beecher announced that the Denton County Bar Association's Wills for Heroes program is assisting members of the Denton County Sheriff's Department this year, the program provides free wills to employees and their spouses. Paralegals are needed to draft documents and to notarize at the will-signing event on May 31, 2014.
- 8. President Guertler reminded members to renew their membership if they have not already done so.
- 9. CLE Chair Michelle Beecher introduced the speakers, Earl Dobson and Rick Daniel, who gave a presentation titled, "Understanding the Various Types of Sexual Charges". Upon the conclusion of their presentation, CLE Chair Beecher presented Mr. Dobson and Mr. Daniel with trophies and certificates of appreciation.
- 10. CLE Chair Beecher announced that Hugh Coleman would be the speaker in March presenting information on employment law.
- 11. President Guertler reminded everyone about the April 10th social.
- 12. The speakers drew the name of the door prize winner: Cheryl Cooper who won a \$25 iTunes gift card donated by Randolph W. Stout, P.C.
- 13. There being no further business, President Guertler adjourned the meeting at 1:00 p.m.
